Governments Pay Millions to Covid Criminals

Europe, The Netherlands

Anti-money laundering investigations in Europe and counter-terrorism operations in MENA revealed growing illegal money streams to North African crime syndicates. Money derived from the Covid vaccination and testing businesses in Europe.

The Dutch government pays through the Open Netherlands Foundation for (mandatory) Covid tests that have not been performed.

Het doel van de Stichting Open Nederland is een bijdrage te leveren aan het heropenen van het sociale leven in Nederland. The CoronaCheck app

The Open Netherlands Foundation (Stichting Open Nederland) aims to contribute to the reopening of social life in the Netherlands. They facilitate test appointments with various test providers via a **Testing for Access** platform. With a negative test result, a corona admission ticket can be obtained in the CoronaCheck app of the central government or printed via [coronacheck.nl](https://www.coronacheck.nl).

De Stichting speelt een faciliterende rol in dit proces met een centraal afsprakenportaal op testenvoortoeegang.nl en door het inzichtelijk maken van de testvraag en het verzorgen van de benodigde IT-faciliteiten.

Paid per test

Test providers are paid per test and indicate where, when, and how many people they can test. In this way, the market can intervene with a demand for corona tests.

Testing for Access

Several commercial parties are active as test providers for **Testing for Access**. Parties that want to register as a test provider have ample opportunity to do so.

Subcontractors

We found that a significant number of accredited test providers also work with subcontractors that operate their drive-through testing facility.

Corruption

Criminals pay organizations and companies with more than 30 employees to have their staff tested or change to (criminal) test providers. Even some individuals earn 20 thousand euros per month for recruiting their family and friends for testing.

Mandatory testing supported by organized crime

Organized crime supports the political movement for Mandatory Testing, emphasizing the role of commerce to make (weekly) mass testing possible.

Millions

In at least three European countries, more than 10% of the drive-throughs and mass testing for companies are controlled by organized crime. MDs are attached to the facilities to avoid in-depth checks by law enforcement.

Skewed and manipulated statistics

Thousands of original details of once-tested persons are pushed through the system more often to collect additional government funding. Thus significantly increasing the total numbers of tests and positive or negative results reported by government officials.

Any day of the week, organized crime can fine-tune the outcome of official Covid testing numbers, and some do.



FIX THIS
